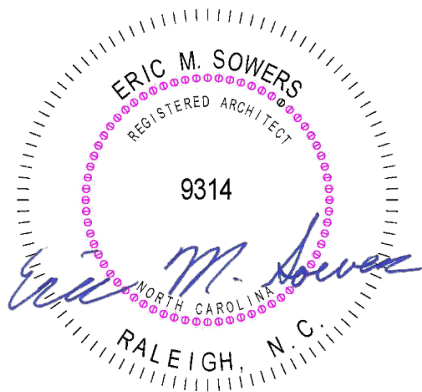

Sealed proposals will be received by the County of Wake in the Purchasing Department, Suite 2900, Wake County Justice Center, 301 McDowell Street, Raleigh, NC 27601, up to 4:00 p.m., April 20, 2021, and immediately thereafter publicly opened and read for providing labor, material and equipment entering into the construction of The WAKE COUNTY PSC SKYLIGHT & PSC & L BLDG FALL PROTECTION project, located in Raleigh, NC.

The work consists of the replacement of three existing skylights with a new roof structure and clerestory windows, a new entrance curtainwall, and fall protection at the Wake County Public Safety Center 330 S. Salisbury Street Raleigh, NC 27601. The work also consists of fall protection at the L Building Parking Deck north and south stair towers.
